

RESOLUTION NO. 6

A RESOLUTION requesting the Election Board of King County to call a special election to submit the proposition of constructing betterments to the Water System of the Town of Redmond and of issuing not to exceed Eighteen Thousand Dollars of Water Revenue Bonds in part payment therefor.

WHEREAS the Town of Redmond now owns its water system, which consists to large extent of wooden water mains which are now in such condition that they must be replaced in the near future; and

WHEREAS the Town Council deems it more economical and advisable to replace the said wooden water mains with cast iron mains, and the total cost thereof will be, as nearly as may be estimated, the sum of Thirty Thousand Dollars (\$30,000.00); and

WHEREAS there is unemployment and need in and about the Town of Redmond, and the immediate making of such improvements would place a great many persons at work; and

WHEREAS the United States of America and/or the State of Washington through their emergency relief appropriation agencies now engaged in instituting and encouraging the institution of public works so that the unemployed may be put to work, have agreed to contribute one-half the cost of replacing the said wooden water mains with cast iron mains on condition that the work start immediately; and

WHEREAS a large number of the qualified voters of the Town of Redmond gathered at a public meeting called by the Town Council on the evening of July 19, 1933, did express themselves unanimously in favor of this improvement and its immediate institution and the issuance of the Water Revenue Bonds necessary to pay one-half of the cost of this improvement; and

WHEREAS the Town Council of the Town of Redmond deems it advisable and necessary to immediately hold a special election for the purpose of authorizing the institution of said improvement;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF REDMOND that it is advisable and necessary that a special election be called for Tuesday, August 8, 1933, for the purpose of submitting to the qualified voters of the Town of Redmond for ratification or rejection, the proposition of the adoption of a system and plan for additions and betterments to the water system of the Town of Redmond, consisting of replacing the existing wooden water mains with cast iron mains, and the issuance of not to exceed Eighteen Thousand

Dollars (\$18,000.00) of Water Revenue Bonds in part payment thereof, and does hereby respectfully request the Election Board of King County to call a special election for the said 8th day of August, 1933 in the Town of Redmond, for the purpose of submitting the said proposition to the qualified voters of said Town.
