AMENDING THE USER FEE SCHEDULE FOR DEVELOPMENT SERVICES USER FOR PLANNING/ENTITLEMENT ADOPTED RESOLUTION NO 1214, ADOPTING NEW PERMIT FEES FOR MASTER PLANNED DEVELOPMENTS. PROVIDING THAT ALL SUCH FEES SHALL SUBJECT TO A TECHNOLOGY SURCHARGE AND TO PERIODIC INCREASES, AS PROVIDED IN ORDINANCE RESOLUTION NO 2090, 1162, RESOLUTION NO 1214, AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, Resolution No 1214 of the City of Redmond adopted an amended user fee schedule for the Redmond Planning Department effective March 1, 2006, and

WHEREAS, Resolution No 1221 of the City of Redmond modified the effective date of Resolution No 1214 to May 1, 2006, and

WHEREAS, City of Redmond Ordinance No 2447 effective April 8, 2009, requires that the user fee schedule be amended in order to reflect adoption of a new permit relating to Master planned Developments, and

WHEREAS, the new permit fees should be subject to the annual adjustments for inflation authorized by Resolution No 1214 and to the technology surcharge authorized by City of Redmond Ordinance No 2090 and extended by City of Redmond Resolution No 1162

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS
