

**ASSIGNMENT AGREEMENT**

**THIS ASSIGNMENT AGREEMENT** (the "Assignment Agreement") is entered into this 1st day of October, 2017, by and between Snohomish County Fire Protection District No. 1, a Washington municipal corporation (the "**Assignor**"), the City of Redmond, (the "**Contracting Entity**"), and South Snohomish County Fire & Rescue Regional Fire Authority (the "**Assignee**").

**WHEREAS**, Assignor and Contracting Entity entered into a cooperative purchasing agreement dated January 18, 2011 (the "Contract"), a copy of which is attached hereto as **Exhibit A**; and

**WHEREAS**, Assignor has, as of October 1, 2017, ceased to operate and instead has been replaced by the newly formed South Snohomish County Fire & Rescue Regional Fire Authority (the "Authority") pursuant to Chapter 52.26 RCW; and

**WHEREAS**, pursuant to RCW 52.26.100, all functions and duties of the Assignor are to be transferred to the Authority upon its creation.

**NOW, THEREFORE**, the parties agree as follows:

1. **Assignment and Assumption.** Assignor's interest in the Contract is hereby assigned to the Assignee, and by entering into this Assignment Agreement the Authority hereby accepts said assignment and agrees to assume said interests, duties, and obligations.
2. **Notice.** Any notices to be provided to Assignor under the Contract shall, commencing on October 1, 2017 be given as follows:

3. **Consent of Contracting Entity.** The Contracting Entity hereby consents to this Assignment Agreement and the terms and conditions set forth herein.
4. **Other Terms and Conditions.** All other terms and conditions of the Contract shall remain unchanged and in full force and effect.

**COOPERATIVE PURCHASING AGREEMENT BETWEEN THE CITY OF REDMOND AND  
SNOHOMISH COUNTY FIRE PROTECTION DISTRICT NO. 1**

**INTERGOVERNMENTAL COOPERATIVE  
PURCHASING AGREEMENT**

In accordance with RCW Chapter 39.34 and to all other applicable laws, the Snohomish Co. PD#1 and the City of Redmond, hereby agree to cooperative governmental purchasing agreement for various supplies, materials, equipment and services, using competitively awarded contracts. The following terms and conditions shall apply:

1. Each agency, in contracting for the purchase of supplies, materials, equipment and services, agrees at its discretion, to extend contracts for shared use to the extent permitted by law and agreed upon by those parties and suppliers.
2. Each agency is responsible for compliance with any additional or varying laws and regulations regarding purchases.
3. Any purchases shall be effected by a purchase order from the purchasing agency and directed to the supplier(s).
4. The originating contracting agency does not accept responsibility or liability for the performance of any supplier used by the purchasing agency as a result of this agreement.
5. Each agency shall be responsible for the payment of any item(s) purchased through a contract or purchase order that resulted from this Agreement.
6. Each agency reserves the right to exclude the other from any particular purchasing contract, with or without notice to the other party.
7. This Agreement shall remain in force until cancelled by either party, which cancellation may be effected by ten (10) days written notice to the other party.
8. This agreement covers all City contracts.
