## HEARINGS AND REPORTS

### STAFF REPORTS

a. AM No. 11-023: 2010 Fourth Quarter Financial Report

Mr. Mike Bailey, Finance and Information Services Director,  
provided the Mayor and Council with the Fourth Quarter  
Financial Report, noting that closing numbers are still  
pending. The report addressed:

- year-end work still to be done;
- overall General Fund numbers, based on actual as of  
January 10, 2011;
- General Fund Revenues - preliminary numbers do not include  
sales tax accruals for November and December 2010;
- sales tax;
  - collections through October \$32.1 million;
  - 2009 collections \$17.9 million;
  - 2010 collections expected at \$18 million;

- Based on trends, collections running approximately \$500,000 below revised forecast through October (includes audit adjustment of \$290,000 in early 2010)
- utility tax;
  - projected overall decline of ten percent in 2009 and twelve percent in 2010, as compared to original budget;
  - preliminary numbers approximately eight percent or \$2 million under revised forecast;
  - cellular, electric, gas, and general telephone are all lagging behind;
- development;
  - forecasted decline of:
    - 2009 = 33 percent compared to budget (\$1.6 million);
    - 2010 = 43 percent compared to budget (\$2.1 million)
    - Based on revised estimates within Planning Department;
  - Preliminary numbers indicate actual collections approximately in line with forecast; and
- General Fund conclusion;
  - end of year numbers are still preliminary;
  - goal was to retain all of economic contingency (\$2.9 million);
  - economic contingency budgeted at \$2 million for 2011-12 (funded from 2009-10 ending balances);
- final year-end numbers are expected in March for the General Fund and other funds.

b. AM No. 11-024: Frontier Communications Cable Television Increases

Ms. Jane Christenson, Deputy City Administrator, and Mr. Patrick Hirsch, Audio/Visual Operations Manager, provided a report to the Members of the Council regarding Frontier Communications notice of proposed rate increases for cable television services, affecting over 2000 Redmond City customers.

Members of the Council discussed the various local cable channels, including the City of Redmond's cable channels that will no longer be available to those Frontier customers switching from cable television to other types of service.

c. AM No. 11-025: Redmond's Neighborhood Program: 2011-12

Ms. Kim Dietz, Senior Planner, provided a report to the Members of the Council regarding the status of the City's Neighborhood Program. The report included achievements in the program in 2010, planned program enhancements in 2011, and program milestones.

d. AM No. 11-026: Tree Fund Update

Ms. Cathy Beam, Principal Planner, provided a report to the Members of the Council regarding the status of the City's Tree Replacement Fund; noting the number of trees that have been planted during the ten years of the program, the location of the replacement trees, and an account balance of \$8,500. Ms. Beam noted that staff will be meeting next week to discuss spring planting.

e. AM No. 11-028: Response Report: 2010 Rain Event - December 11<sup>th</sup> and 12<sup>th</sup>

Mr. Jon Spangler, Natural Resource Engineering Manager, provided a report to the Members of the Council regarding staff efforts to address the December 2010 Rain Event. Discussion took place in regards to addressing impediments caused by the storm such as: leaves, debris, river surcharge, groundwater, land slides, streams, and road closures. Construction project delays, as well as Police and Fire Departments' coordination, were discussed.

f. AM No. 11-029: Redmond Code Rewrite: Final Development Standards Package (L090380)

Ms. Lynda Aparicio, Senior Planner, provided a report to the Members of the Council with regards to the final proposed zoning code rewrite, Final Development Standards Package. Ms. Aparicio overviewed the process to-date and noted that this package contains 18 items for the Council's consideration; discussion to be held at a study session of the Council scheduled on January 25, 2011.

The following information/follow-up/comments were received:

- regarding item B9: Councilmember Margeson requested additional information with regards to landscape area, ponding, etc;

- Councilmember Cole noted that he would like to have portable sandwich board signs placed in the parking lot for further discussion; and
- Councilmember Cole queried regarding the deletion/rearrangement of key definitions and asked that this be clarified further at the upcoming study session.

At this time, Councilmember Cole and Members of the Council spoke regarding Fire Chief Tim Fuller's retirement and the work that he has done for the City of Redmond; and thanked him for his leadership.

#### OMBUDSMAN REPORT

Councilmember Vache reported he received a citizen inquiry with regards to the Mayor's salary; staff has responded.

Councilmember Carson reported he received a citizen contact with regards to high water in West Lake Sammamish Parkway areas.

Councilmember Stilin reported he received a citizen contact with regards to unsolicited phonebook distribution in the City.

- regarding committee engagement of the King County Council on transportation service.

Councilmember Carson advised that the Lodging Tax Advisory Committee will meet this Thursday at 8:30 a.m., at City Hall.

Public Administration and Finance Committee

Councilmember Margeson reported regarding the January 11, 2011, Committee agenda and overviewed the items discussed at that time.

Suburban Cities Association - Public Issues Committee

Councilmember Margeson noted the Committee met last Wednesday and approved their operating policies and adopted a work plan for the year. He further noted a recommendation to King County to renew the veterans and human services levy will be discussed in February.
